## DISCUSSION/ACTION ITEMS

- Discussion of School Safety – Superintendent Canalez reported that the Freshmen Boys Basketball coach received a text from a parent who overheard a conversation between the basketball players regarding a school shooting. The coach reported the comments made to Mr. Brewer and Mr. Brewer reported the incident to administration. Supt. Canalez stated that another incident took place during the (9/28/18) Imperial Football game, a few 9<sup>th</sup> grade students were escorted out of the Imperial game; the students were disrespectful to fans and the officer as well. The officer reported those students to Mr. Smith on Friday evening.

Supt. Canalez also reported on the social media posting regarding a potential school shooting planned for Wednesday, October 3, 2018. He stated that police department had been notified of the incident. Law Enforcement have been investigating the situation involving the 9<sup>th</sup> grade students. He stated that a search was being conducted through the BUHSD computer system for any illegal searchings' by BUHS students.

Trustee Wilson requested a message be sent out to the parents informing them that the district takes all threats seriously and is working to resolve the issue.

Trustee Fernandez stated that he also believes the district should provide a press release on the possible threat and that the district is doing everything necessary to provide and ensure student and staff safety.

President Sassie also would like to have information go out to parents and staff.

Supt. Canalez stated that the Police Department is investigating the situation along with the SRO and Administration. The tech department is conducting a search on the school computer system for any illegal searches. He stated that at this time there is no concrete information on the threat. However, we will not know until the investigation is completed.

President Sassie stated that security as well as all staff need to be very diligent and extra careful.

Trustee Wilson would like for security personnel to be informed.

Supt. Canalez will be holding a meeting at 7:00am to inform the security personnel and will be calling in the security subs for assistance. He stated that 2 minors have been arrested at this time but is unsure of the charges and a 3<sup>rd</sup> student is being investigated.

Trustee Wilson stated that a notice should be sent out to the parents regarding the social media posting.

President Sassie stated that we should state that the district is taking this threat very seriously and the safety of our students and staff is our highest priority.
