## RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

I/We further understand that under California Education Code Section 35330 the District is not liable to the student in any event for any injury, accident, illness or death occurrence during or by reason of such excursions or field trips.

However, in consideration of the District permitting us to transport our child at any point during said field trip and/or excursion the Understanding Hereby Releases, Waives, Discharges and Covenants Not to Sue the District from all liability to the undersigned for any loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the undersigned, whether caused by the negligence of the District or otherwise, while the undersigned is undertaking the transportation of the student to, during, or from the field trip or excursion.

The undersigned Hereby Agrees to Indemnify and Save and Hold Harmless the District, its employees, agents, and officials from any: liability, claims suits or actions; alternative dispute resolution, losses, expenses, fees, or costs of any kind, whether actual, alleged or threatened; administrative and regulatory proceedings; and any other costs or expenses of any kind whatsoever without restriction or limitation; so long as such things are in relation to , as a consequence of, arising out of, or in any way attributable actually, allegedly or impliedly, in whole in part, to the undersigned providing transportation for the student as described above.

The Undersigned further expressly agrees that the foregoing Release, Waiver and Indemnity Agreement is intended to be as broad and inclusive as is permitted by the law of the State of California and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect

The Undersigned Has Read and Voluntarily Signs the Release and Waiver of Liability and Indemnity Agreement, and further agrees that no oral representations, statements or inducement apart from the foregoing written agreement have been made.
